### Transactive Energy Conference 2014

A tentative time to hold the 2014 Transactive Energy Conference was set for the week of April 28, 2014, but due to the previous GreenTech Media event there is a concern of conference fatigue. Discussion continued regarding the timing of the event and the time needed to prepare and execute another successful event. The Council determined that it would be beneficial to reinvigorate the December time slot originally held by the council and push back the 2014 Transactive Energy Conference to early December of 2014.

James Mater discussed the date change with Smart Grid Oregon at their last board meeting and reported that they are committed to the new December date.

The new proposed dates for the 2<sup>nd</sup> International Energy Conference range from December 9-12, 2014. Discussion continued and it was decided that the conference should be held on December 9-10, and the GWAC meeting following day, December 11, 2014. The meeting will be held in Portland, Oregon.

### **Power Industry Transformation Summit**

## **Transactive Energy Framework**

### Ron Melton, GWAC Administrator

A logo has been created for the Transactive Energy Framework document.

Ron Melton asked for input on the substance of the text. Comments have been received comments from Mark Knight, Ken Wacks, James Mater, Tom Sloan, Ward Camp and Jeff Taft.

Additional input is needed from:

- Ron Ambrosio Section 4.3 text to go with figures
- Jeff Taft Section 2 context for control system evolution
- Paul De Martini Comments on section 2 and 4.1 and 4.2 needed

Discussion continued on the framework draft. Ken Wacks suggested that we tighten up the tiered nature of the document. Mark Knight suggested that the Council follow-up with a three page document following the release of the Transactive Energy Framework. Jeff Gooding wanted to identify triggering points that would be the drivers for a utility to move in this direction. Ron Ambrosio pointed out that this could be done in a manner similar to the Interoperability Context Setting Framework.
