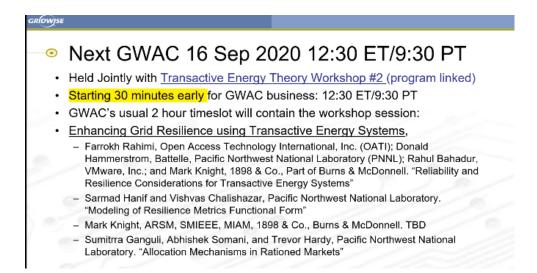

Karen reviewed the progress on TESC20. The group will identify panel moderators, keynote speakers and finalizing the agenda.

Farrokh noted that 50 paper and panel abstract submissions were submitted, and all have been reviewed. There were 24 panel submissions and 31 paper submissions. There were 18 panel accepted panel submissions and 3 were borderline but will be offered the opportunity to submit a paper.

Paper presenters have been notified and they are writing their full papers now.

Karen feels there should be a session chair for each panel based on how things were done previously. This role will ensure a high-quality panel session.

Farrokh noted that we need to assist panelists with guidance on how to prerecord their sessions.

Kay asked about the regulatory panel. Kay had submitted a paper on that topic which was rejected but would be interested in doing it as a panel on regulatory and policy. Kay has 30~ people from the Maine climate change council and they would likely attend since it's virtual. Maine is in the middle of a massive policy change that will push grid modernization and TE, real-time pricing and more. Kay has been working with the Maine climate change council. Since the conference is now all engineering, she will not invite them. She would like to see the great ideas of the GWAC get out into the mainstream.

Tanya is concerned that we are getting too detailed and it may slow the progress of the conference. She also noted that a comprehensive effort to promote the conference needs to be underway. If we could create a content calendar and starting to promote specific panels on social media now that it will help us to gain participants. She suggested sending specific topic suggestions directly to the abstract committee for them to sort. She feels we should be recruiting participants now with a content calendar and social media announcements about topics and speakers.

Ken Wacks said the abstract selection committee does not choose topics. He asked if the group could address Kay's concern that we should do more outreach to regulators.

Farrokh confirmed that there were no abstracts on regulatory and policy submitted for a panel session. He would like to consider teaming with NARUC to fulfill that topic for this conference.

Kay said there are a lot of people who could be encouraged to put in panel presentations including Lynn Kiesling. Kay said this topic for a panel was discussed in Orlando at the January meeting.

Jeff Morris said he and Chris had offered to put a panel together for this. They would still be willing to work to put a panel together. Jeff has talked with some people from Maine also and he would be willing to work on this if the Council wants it to happen. He said there is still enough time to do it.

Ron Melton said that it should be discussed further at the next TESC20 organizing committee meeting.

**Chris Villarreal** said he would be happy to help on regulatory; the challenge is the conflict with the <u>NCEP</u> meeting (affiliated with NARUC), which is why he and Mark Knight have been working on trying to have a shared meeting. The NCEP is also a 3-day meeting.

Chris also noted that for NCEP, the potential joint Session for Dec. 8 would be from 12:15pm to 2:30pm and would be live. He and Mark would be happy to coordinate with TESC20.

Kay said that regulatory legislators must understand what the play space is with TE.

Karen thought it best to defer a decision until the TESC20 Organizer meeting on Monday.

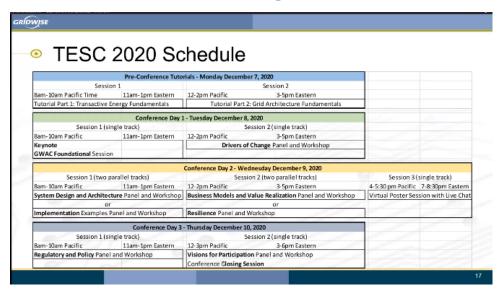
David recognized that we now have enough volunteers willing to work to make this happen.

ISO/IEC JTC 1/SC 25 - Ken Wacks thanked Mark Knight for his help with the TE Framework. All tech reports must be put in the format of a standard. Certain words like shall and must have to be deleted. So work is still going on the framework. Mark gave an opinion about a remaining word "must." Richard Cook is the current editor.

Ken said the next ISO/IEC International meeting will be held on Sept. 14. He is chairing the committee and can invite guests. Anyone wanting to become a member or to participate please contact Ken.

SEPA - Aaron Smallwood; SEPA held the virtual grid evolution summit. It was the first one they have done as virtual. Attendance was 541. The online and on demand contact was released on July 12. On Sept. 22 - 24 the working groups will meet. Non-SEPA members will have a registration fee of \$199.

Aaron noted that the SPI meeting will be all virtual this year. Content will be spread out. The program is coming together very well.

The SEPA catalog of standards is coming along and a press release will go out.
